Office update: Staff is doing the daily data entry along with scanning in VAC cards in to MDVOTERS. However, we have had big issues with the City's Workday system. This is the system that the City uses for paying their bills, ordering of materials etc.

Warehouse update: Staff is getting the old pollbooks prepared to be shipped back to the State Warehouse in preparation of receiving the new pollbooks.

ASSISTANT ATTORNEY GENERAL'S REPORT:

Mr. Chapman said it is great to meet the new board and is looking forward to working them and it has been a pleasure working with the old board. We are looking at a lot of petition measures this year we believe because we have already received approval requests.
